The Chairman welcomed County Councillor Kiddle Morris who had been elected following the County Council elections on 4 June.

# 1. Apologies for absence.

An apology for absence had been received from Councillor Silk who was ill and this was accepted. Councillor Silk will be written to thanking him for all his work over the past few years on the Parish Council. Breckland Council are to be informed to put in place the due process for filling the vacancy.

#### 5.1.3 Parish groupings for S106 payments.

Breckland Council is consulting Parish Councils on the groupings for payments received under S106 agreements for spending on children's play and outdoor sport. The money would be in a pot for a group of parishes to bid for and a committee of Parish Council representatives and Ward Members would decide the allocation. Concern was expressed that the Ward Member is also the Chairman of Gressenhall Parish Council and could have a conflict of interest. Breckland Council would be contacted to raise the concerns of the Parish Council.

#### 5.2 Open Spaces.

#### 5.2.1 Update.

Norfolk woods and Hedges would cut the trees and bushes to the rear of the properties on Birch Avenue to the height of the fence at a cost of £80. Anton Crisp had confirmed that the cost of cutting the hedge at East Bilney Town Lands would be £75 in July and £150 for a further cut in January. This was accepted and he will be informed to proceed. Councillor Luck would confirm at the next meeting if a full cut of the Town Lands is needed or just to cut a walkway through and to leave the rest for the increasing canopy from the trees to keep the grass down.

#### 5.2.2 Cutting of the central area of Beetley Meadows.

Two letters had been received from parishioners complimenting the Parish Council on the improved conditions now the area has been cut earlier.

#### 5.2.3 Parish Walk.

This was agreed as 8 July meeting at the New Inn at 1830 and walking from the Town Lands back to the New Inn.
